## Railway Systems Suppliers, Inc. Policy on Entertainment

(Adopted for use at the 2020 RSSI 60<sup>th</sup> Annual C&S Exhibition)

Dear RSSI Member,

The RSSI Board of Directors revised the exhibition entertainment policy in order to provide common entertainment venues for RSSI members and customers.

The RSSI entertainment policy focuses on the exhibits and the opportunity for our members to showcase their products, services and technology to our attendees. This entertainment policy allows all RSSI member companies, large and small, an equal opportunity to participate in the entertainment of our railroad, transit and government customers. The hospitality events sponsored by RSSI have proven to be a success.

The RSSI sponsored events for the 2020 60<sup>th</sup> Annual C&S Exhibition will include a Beer & Wine Reception on Monday Night, June 1st and a Reception, Dinner and Casino Event on Tuesday Night, June 2nd. Details are available on the RSSI website at <a href="https://www.rssi.org">www.rssi.org</a>.

RSSI entertainment rules will apply from Monday, June 1<sup>st</sup> through Wednesday, June 3<sup>rd</sup>. Private member hospitality rooms are not permitted, and no organized private entertainment is permitted. Members are expected to participate in the common hospitality events.

NOTE: RSSI member private hospitality rooms are strictly forbidden.

All RSSI members are expected to comply with this policy.

By signing the exhibitor contract and/or registering for the 2020 Exhibition, you are certifying that all representatives and associates of your organization have been notified of the RSSI revised policy on entertainment and will observe and abide by this policy.

## RSSI 2020 GENERAL EXHIBIT & SOCIAL ACTIVITY RULES

- NO children under the age of 18 are permitted to attend the RSSI sponsored social events.
- Children ages twelve to eighteen (12-18) are permitted to visit the exhibition during show hours if accompanied by an adult at all times. Children under 12 are NOT permitted on the exhibition floor at any time.
- <u>Exhibitors:</u> Must abide by the Rules and Regulations included in the Exhibitor Service Manual
