# **A Letter from the President**

I consider myself fortunate to have been associated with the railway industry for most of my life. My roots go deep, beginning with my father, who joined the staff of Railway Age (which my company, Simmons-Boardman, has been publishing since 1908) more than 80 years ago. I'm equally fortunate for the opportunity to serve as President of RSSI, an organization whose core mission is strengthening the bonds that connect the suppliers who provide communications

and signals systems—the safety-critical technology that supports our world-class industry, and that is growing and changing at a rapid pace.

One of my former editors, the late Luther S. Miller, often talked about the concept of "connective intelligence." That's what we provide RSSI member companies through our annual C&S Exhibitions—our primary function—where suppliers of technologies ranging from wayside signals, PTC/CBTC, microprocessor interlockings and communications networks to grade crossing warning systems, fault detection, Information Technology, equipment tracking, computer-aided dispatching and many more spend quality time with their customers on the exhibit floor and at RSSI social events.

The strong attendance at the 61st Annual RSSI C&S Exhibition in Kansas City in May 2022 speaks to the loyalty of the RSSI customer base. We welcomed more than 1,400 railway suppliers and their rail customers. We proudly displayed the RSSI logo and colors on every streetlamp in the downtown area. More than 160 exhibitors utilizing 150,000 square feet of exhibit space and two food courts serving breakfast and lunch hosted more than 300 rail employees from all North American Class I railroads, and several Class II and III carriers, rail transit agencies and Amtrak. RSSI again hosted well-attended evening social events featuring interactive games, food stations and quiet areas where long-time friends and business associates were able to spend time together in person—a welcome change following more than two years of the COVID pandemic.

Among the many railways in attendance at the 2022 exhibition were Amtrak, BNSF, CN, Conrail Shared Assets, Canadian Pacific, CSX, Iowa Interstate, Kansas City Southern, Metra, St. Louis Metrolink, Metra, Northern Indiana Commuter Transportation District, Norfolk Southern, Union Pacific, Ferromex, Smoky Hill Railway, Reading & Northern, Placerville & Sacramento and—from Scandinavia—Khalifa Transport, Norway.

The exhibit floor included an Innovation Theatre, where several RSSI member companies gave product presentations to select groups of C&S engineers without taking customers out of the exhibit hall. Since the headquarters of Kansas City Southern and BNSF's Argentine Yard are both located in Kansas City, many rail C&S managers and field employees who may not normally be able to attend the annual exhibition were able to join us. As well, several RSSI member companies headquartered in the Kansas and Missouri areas were able to take advantage of the exhibition and send attendees.

AREMA hosted a C&S Symposium where papers and seminars on C&S projects were presented to more than 200 attendees. RSSI and AREMA have always enjoyed a close relationship. In fact, many signal engineers and C&S suppliers are members of five AREMA Technical Committees within the Communications, Signals & Information Technology Functional Group. These members are tasked with development and revision of the AREMA Communications & Signals Manual, a key part of making sure that components and software are built and maintained in a safety-critical manner.

In 2023, the RSSI C&S Exhibition will be part of the semiannual Railway Interchange Exhibition in Indianapolis, September 30 to October 3. A joint presentation of RSSI, AREMA, REMSA and RSI featuring hundreds of companies from all areas of the railway supply industry, Railway Interchange is not to be missed—part of the tremendous value that RSSI has provided its member companies since 1966.

We value your membership, thank you for your participation in Kansas City, and look forward to seeing you next year in Indianapolis.

# **Philanthropist With Local Ties Dies at 83**

Ronald McDaniel made impact on youth club, arboretum, colleges

A Richmond High School graduate continued providing opportunities for local children long after he moved away, and stayed engaged with Wayne County until the end of his life.

Ronald L. McDaniel, 83, died June 23, but will be remembered for his support of local organizations such as Boys & Girls Clubs of Wayne County, Hayes Arboretum, Ivy Tech Community College and Earlham College through a foundation bearing his name.

McDaniel made his mark in the railroad and railway supply community over more than five decades. He started working for Hayes Track Appliance Co. in Richmond in 1957, the same year he graduated from Richmond High School.

He took some classes at Earlham College and the former Indiana University Education Center at Earlham, but needed to pursue night courses outside working hours. He earned a bachelor's degree in accounting at University of Dayton in

After becoming a certified public accountant, McDaniel later earned a master's in business administration from University of Chicago.

Federal Signal in Chicago bought Hayes Track in 1969, and McDaniel held various management roles with Federal Signal and Western-Cullen-Haves. In 1990, McDaniel bought Western-Cullen-Hayes, which makes railroad-grade crossing warning devices and other track safety products. McDaniel also held leadership positions in his industry.

including board member and president of Railway Systems Suppliers Inc., and Railway Engineering and Maintenance Supply Association, according to Railwayage.com.

In 2015, McDaniel was recognized at the local Boys & Girls Clubs' Smart Futures Dinner for his business success and impact on others. He became a trustee in 2016, and in 2017, the Ronald L. McDaniel Foundation Boys & Girls Club opened on Richmond's west side.

"Ron was a philanthropic force in Wayne County, enhancing our community by supporting a number of local organizations," Boys & Girls Clubs of Wayne County Chief Executive Officer Alicia Painter said.

Painter noted McDaniel provided knowledge, steady guidance and leadership, and his big smile and high-fives to youth would truly be missed.

Painter also noted, "The legacy Ron has made on our organization will continue to positively impact thousands of youth for years to come. His kind heart and genuine smile will be deeply missed."

McDaniel also made an impact on Hayes Arboretum as a longtime board member. A few years ago, the arboretum created the Ronald L. McDaniel Award for Charitable Giving to recognize outstanding philanthropic support for its environmental education.

Two Richmond colleges have recognized McDaniel's generosity to higher education. Ivy Tech Community College is home to McDaniel Hall, and Earlham College has a studio theater and a chair of management studies named after him. He previously served on Earlham's foundation board.

A memorial service took place July 3 in Willowbrook, Illinois.

# Railway Interchange to Return in 2023

The four associations that make up Railway Interchange AREMA, REMSA, RSI and RSSI have agreed to hold the sixth Railway Interchange Conference and Exhibition in Indianapolis in 2023 after having to cancel the 2021 event due to COVID.

RI 2023 will be held from Sunday October 1st thru Wednesday October 4<sup>th</sup> at the Indianapolis Convention Center.

Exhibitor booths will go on sale on October 11, 2022. Registration and hotel reservations will open in the spring of 2023.

The last Railway Interchange event was held in Minneapolis in 2019 and attracted over 8500 rail industry professionals from over 45 countries and 764 exhibitors. Railway Interchange is the largest gathering of rail suppliers and customers in North America.

RSSI member companies will be contacted by the RSSI staff with the time they can call into the RSSI office and reserve their booth.

# Why is It Important for Exhibitors to Not Begin Dismantling Their Booths Early?

RSSI currently has 252 member companies. The RSSI staff regards these member companies as our customers and we work hard to meet their needs.

At our annual C&S exhibition we have between 160 and 180 member companies purchase booth space and exhibit their products and services to the rail customers.

These exhibiting companies and our sponsors pay the entire cost of the exhibition including the food served on the exhibit floor, the open bars and food served at our social events, the convention center, signage, decorator costs, wifi, electrical hook ups and many more associated expenses. These exhibitors are the backbone of our association.

So why is it that at every exhibition as the final hours of the exhibition drag by and there are few customers in the exhibit hall that the RSSI staff and security personnel find themselves involved in confrontations with exhibitors who are tearing down their booths prior to the scheduled and posted time of the exhibit close.

The answer is liability. RSSI pays several thousand dollars in liability insurance for each exhibition. This insurance policy requires that RSSI follow all rules of the exhibition including no open toed shoes during setup and tear down and that the hall is clear of customers and guests during setup and tear down.

Tear down can be a very dangerous time on the exhibit floor. Hanging signs and exhibit walls are being taken down, the aisles are littered with storage crates, boxes, chairs, and tables. Forklifts are traveling through the halls delivering and removing crates.

If anyone were to be seriously injured during this time, we would rely on our liability insurance to protect RSSI from a major financial loss. If the person who is injured is a customer or guest who is not authorized to be in the hall during tear down the liability insurance is not in effect.

When an exhibitor begins to dismantle his booth prior to the scheduled exhibit closing time there may be customers and guests still in the hall. If one exhibitor begins dismantling it causes a domino effect. A second exhibitor thinks it must be OK and also begins to tear down. Then a third and so on.

When you sign the contract to exhibit with RSSI or any of the trade associations the contract states that you and all of your companies' personnel will follow the exhibition rules. Opening and closing times of the exhibits are posted on signage, in the pocket guide and distributed via email to all exhibitors and attendees.

In addition, announcements are made during the final hours of the exhibition requesting that exhibitors do not begin packing up their booths until they are notified that it is safe to do so.

We do not enjoy confronting and threatening our exhibitors with penalties if they begin tearing down early and will not stop when requested but we must do all we can to enforce the rules.

Please know the exhibition rules and follow them. If you have questions, please consult an RSSI staff member.
